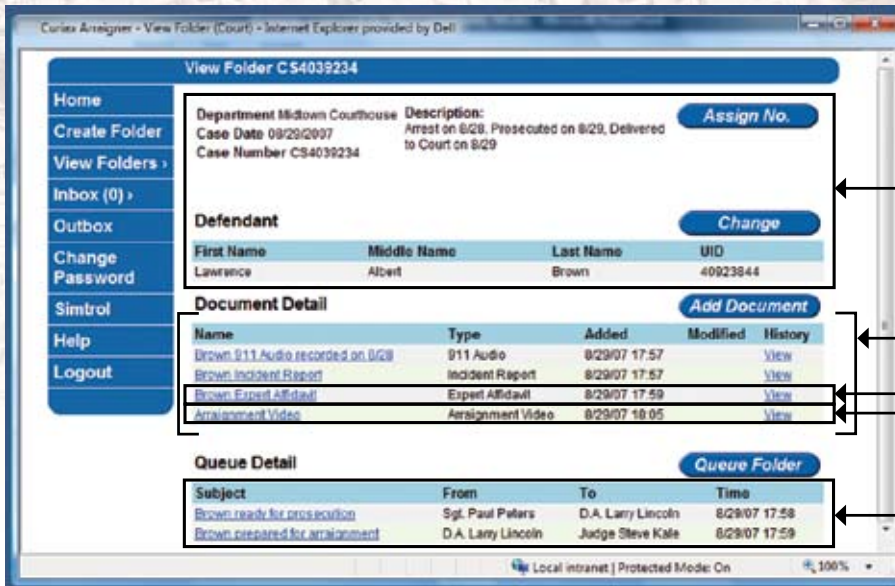

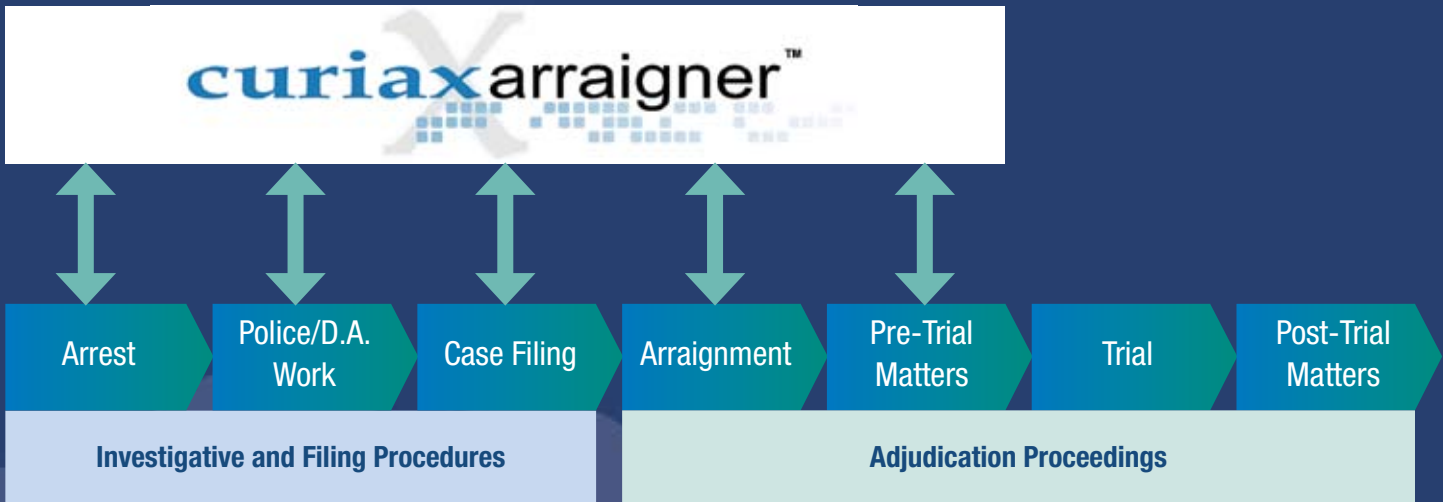
Digital Documents and Signatures – Expedites document completion and approval. Revision tracking ensures document integrity.
